It was noted that the Annual Report would need to include reporting on impact and there was discussion about the best ways for Trustees to get a better understanding of how National Audits are used in Trusts. 	5.3 Trustees acknowledged current recruitment status - there are several important short term		
	staffing gaps.

8.	Concerns about a cardiac surgery service - HQIP, with the audit provider National Institute for

	(CQC) about the quality of cardiac surgery services at Queen Elizabeth Hospital in Birmingham.		
	Subsequently, and not based just on HQIP's concerns, the CQC decided to undertake an		
	unannounced inspection. The Trustees noted the subsequent Press Release issued by the CQC.
